ENFORCEMENT NOTICE OPERATIONAL DEVELOPMENT**Issued by: St Albans District Council**

1. **This Notice** is issued by the council because it appears to them that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. The Land To Which The Notice Relates**10 Cotlandswick, London Colney, Hertfordshire**

Shown edged red on the attached plan.

3. The Matters Which Appear To Constitute The Breach Of Planning Control

It appears to the Council that the following breach of planning control has occurred within the last 4 years.

Erection of first floor extension to create an independent two bedroom dwellinghouse.

4. Reasons For Issuing This Notice

The development has a detrimental impact on the character and appearance of the street scene. The layout of the development is also considered to be contrived and does not relate to the pattern of development in the locality. The resultant unusual site shape to both sites leads to a detrimental impact on the visual amenity of the locality. Contrary to Policy 69 – General Design and Layout (i) and (ii) and Policy 70 – Design and Layout of New Housing (i), (vi), (viii), (ix) and (x) of the St Albans District Local Plan Review 1994.

5. What You Are Required To Do

1. Demolish the unauthorised first floor extension and make good any resulting damage in materials matching the original dwellinghouse.
2. Demolish the roof of the first floor extension and make good any resulting damage in materials matching the original dwellinghouse.

6. Time For Compliance


3 months after this notice takes effect.

7. When This Notice Takes Effect

This notice takes effect on 25 February 2010 unless an appeal is made against it beforehand.

Your Right of Appeal

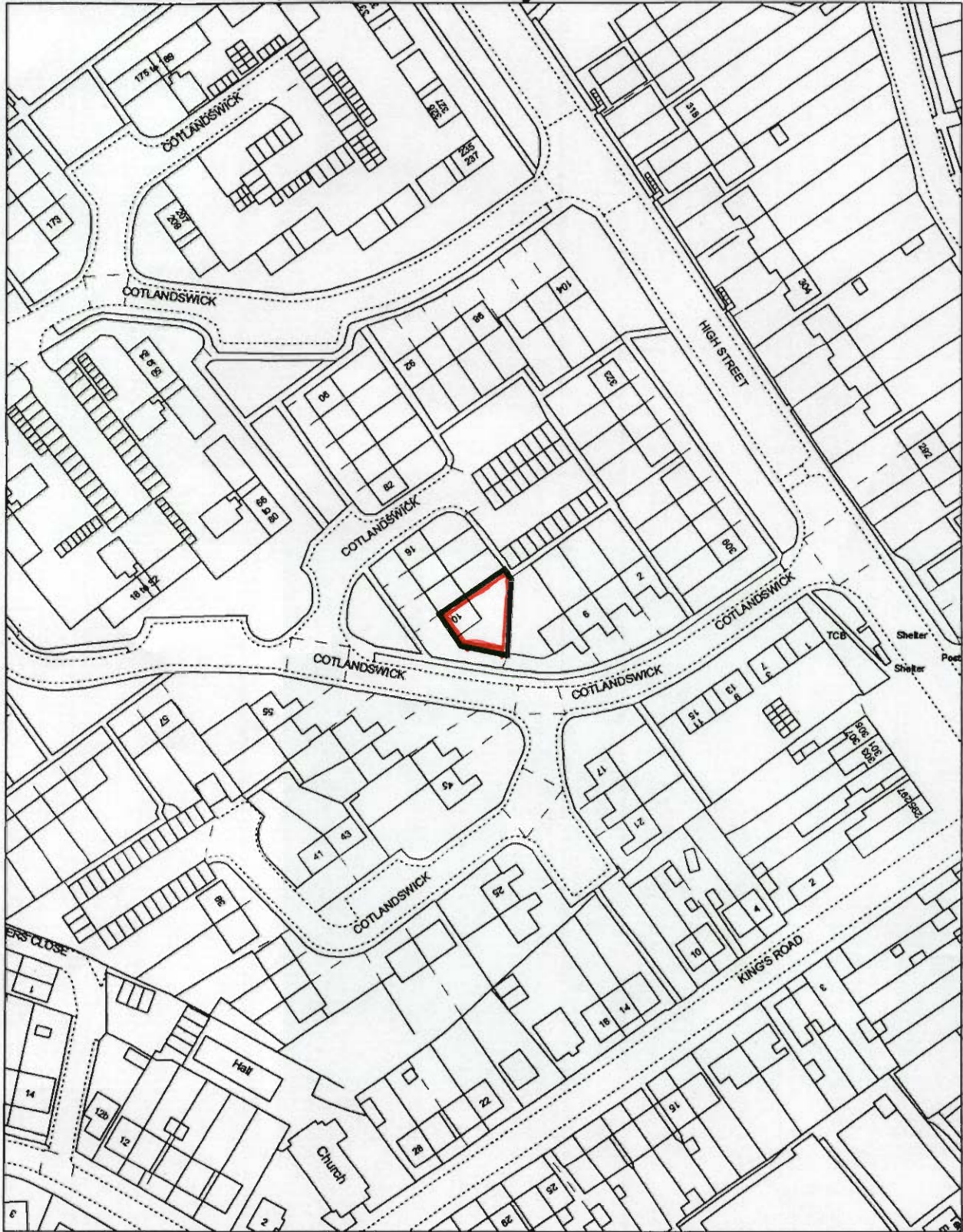
You can appeal against this notice, but any appeal must be received, or posted in time to be received, by the Secretary of State before the date specified in paragraph 7 of the notice. The enclosed booklet "Enforcement Notice Appeals – A Guide to Procedure" sets out your rights. You may use the enclosed appeal forms.

- a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
- b) The second copy of the appeal form and the notice should be sent to the Council
- c) The third copy is for your own records.

What Happens If You Do Not Appeal

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
