THE ST ALBANS CITY AND DISTRICT COUNCIL (CONTROL OF PARKING) ORDER 2023
(AMENDMENT No.7) ZONE VW, THIRLESTANE ORDER 2025

Made 13/03/2025

Coming into force 28/03/2025

St Albans City and District Council, pursuant to arrangements made under section 19 of the Local Government Act 2000 and Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council, and in exercise of powers conferred on that County under sections 1,2, 3, 4, 32, 35, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and the provisions of Part 6 and Schedule 9 of the Traffic Management Act 2004 and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with III of Schedule 9 to the 1984 Act, makes the following Order:

Citation and commencement

1. This Order shall come into operation on 28/03/2025 and may be cited as The St Albans City and District Council (Control of Parking) Order 2023 (Amendment No.7) Zone VW, Thirlestane Order 2025, hereinafter referred to as “this Order”;

Interpretation

2. In this Order:

“**The Order of 2023**” means The City and District of St Albans (Control of Parking) Order 2023;

“**On-Street Plans**” means a map showing the specified location/s within the City and District of St Albans and incorporated into this order, unless otherwise indicated.

Amendment of the City and District of St Albans (Control of Parking) Order 2023

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, The Order of 2023 shall have effect as though the Map Tiles within the Schedule to that Order were substituted with the similarly named Map Tiles as set out in the Schedule to this Order.
4. The restrictions imposed by this Order and detailed on the on-street plan to this order, shall only amend those restrictions shown and detailed, all other restrictions to the on-street plans to The Order of 2023 will remain as detailed on the on-street plans.
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

6. The restrictions imposed by this Order and detailed on the on-street plan, shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
