St Albans City and District Council, pursuant to arrangements made under section 19 Local Government Act 2000 and Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council, and in exercise of powers conferred under the Road Traffic Regulation Act 1984 (as amended) and after consultation with the Chief Officer of Police makes the following Order:

Citation and commencement

1. This Order shall come into operation on dd/mm/yyyy and may be cited as The City and District of St Albans (Control of Parking) Order 2023 (Waiting Restrictions) (Amendment *) Order 202*.

Interpretation

2. In this Order:

“**the Order of 2023**” means The City and District of St Albans (Control of Parking) Order 2023;

“**On-Street Plan/s**” means a map showing the specified location/s within the City and District of St Albans and incorporated into this order, unless otherwise indicated.

“**Key**” or “**Key to the on-street plans**” means a list provided on the on-street plans which contains an explanation of what the different lines and symbols on the individual map/s mean, this will also include specific details of restriction times, days, zone identifiers, or any other relevant information.

Amendment of the City and District of St Albans (Control of Parking) Order 2023

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order, The Order of 2023 shall have effect as though the Map Tiles within the Schedule to that Order were substituted with the similarly named Map Tiles as set out in the Schedule to this Order.
