## PANEL ON A SCHEME OF MEMBERS' ALLOWANCES

NOTICE IS HEREBY GIVEN that the Council of the City and District of St Albans, pursuant to Regulation 22 of the Local Authorities (Members' Allowances) (England) Regulations 2003, has received recommendations from an independent renumeration panel in respect of its scheme of allowances payable to members of the Council. The scheme would take effect from 1 April 2025 until 31 March 2026.

The Independent Remuneration Panel has met in accordance with Regulation 19(1). The main features of the recommendations made by the Panel are as follows:

- (i) A basic allowance for all members of £6,672.34
- (ii) That Special Responsibility Allowances (SRAs) be indexed according to the basic allowance set out in (i) as below:

- (iii) That the allowance payable to each Political Group Secretary be abolished.
- (iv) That the £100 Travel Allowance for Development Management Committee members be abolished.
- (v) That the rate claimable for costs incurred by any member who has a child aged under 14 residing at home be increased in line with the National Living Wage from April 2025 onwards.
- (vi) That the rate claimable for costs incurred by any member who has a dependent relative over the age of 14 be increased in line with the Hertfordshire County Council adult home care rate from April 2025

The commencement date for the scheme is 1 April 2025 and Special Responsibility Allowances are payable

from that date and will be backdated as necessary.
