Personal Profile

I graduated from Liverpool University with an Honours degree in Engineering. I then spent 10 years in logistics and planning, running and designing transport systems and setting up distribution networks. After 10 years I moved into residential estate agency. I set up, and ran a sales and lettings company operating in the local area, which entailed undertaking every aspect of the business including sourcing land for development, interfacing with developers, but most of all ensuring that all clients received a professional service. I trained numerous staff to undertake their roles to a similar professional standard, including valuing properties and interfacing with clients and the public.

After 20 years I sold the business and became involved in addressing local issues relating to planning, specifically applications relating to Green Belt development. This included establishing the local campaign group *greenbelt* and forming a working relationship with other campaign groups around the district, to form the District Green Belt Alliance (DGBA) as well as interacting with local politicians, media outlets and of course supporters. I have been involved in this, on and off over the past 10 years, but have no professional qualification specific to planning issues.

I have lived in Park Street for 32 years, within 25m of the agricultural land in question.

The evidence which I have prepared and provide for this appeal reference APP/B1930/W/24/3343986 in this proof of evidence, is true and I confirm that the opinions expressed are my true personal opinions.

1. Introduction

1.1 I address matters raised in the technical note from Charles Garrard of Ceres Rural (CD9.7), on behalf of the Appellant pertaining to Agricultural matters.

1.2 I will only address additional matters, or such matters that appear to be additional to my Proof of Evidence, although there is inevitably some overlap.

1.3 Lack of comment about other matters, does not represent acceptance of those matters, rather a perception that these are already covered in my Proof of Evidence.

2. Mr Garrard's Comments

- 2.1 It is recognised that just because the land has been successfully farmed for many decades, it does not change its ALC rating, no such claim was ever made. The point made was simply that it had successfully produced a crop on a continuous basis.
- 2.2 Mr Garrard states that a greater range of crops can be grown on 3a land. This is not in doubt, since as already stated in my proof, the slightly stonier 3b land is not as good for growing such crops as potatoes, however this is irrelevant since (to my knowledge) potatoes have never been grown here. Unsurprisingly the farmer has produced grass crops that are little affected by the stonier environment.
- 2.3 Mr Garrard makes a great distinction between 3a and 3b land. Whilst in the two extremes, 3a that is almost 2, and 3b that is almost 4, might display quite different qualities, in his instance we have one, relatively small field of 4.3ha where some is 3a and some 3b. This would strongly suggest that they are not dissimilar in their qualities, albeit the northern end being slightly better. Thus the idea that there are significant differences in the value of the two parts of the same field with regard to crop productivity is rather unlikely.

3. Land Management

- 3.1 As previously stated the farmer of the proposed site also works the adjacent 18.4 hectare agricultural land, part of SA107, typically growing the same crop on both sites. He uses the same machinery on both pieces of land and treats them the same in terms of harvesting.
- 3.2 He has also employed various pest control features over time, including gas bangers, which he has positioned on the far field to minimise disturbance to residents. However, because the sound waves are un-impeded whilst travelling across the open land, they are easily heard inside properties around the Appellant's land.
- 3.3 Additionally he employs "Shooters" to kill pigeons, especially after a harvest and after planting crops for the new season and they are positioned between this field and the adjacent one to the west. Being located on the edge of the tree line, they are out of sight of the birds. Even if there was no requirement to keep the pest birds clear of the development site, there would be a need to continue to protect the fields the other side of the trees, and the firing positions within the trees, provide the cover required for the shooters.

3.4 The noise from these shot guns is extremely loud and quite frightening when heard from the houses surrounding the field and on the northern side of Old Orchard, which are approximately 200m away from the shotgun positions. The shooting often continues for over 8 hours during the summer months.

- 3.4 Should this development proceed, the nearest houses would be as close as 10m from this firing, which would be very disturbing indeed.
- 3.5 If any of the children from the new development chose to play in the adjacent woodland (which would be trespassing), they would be in close proximity to the gunshot, which would pose a danger.
- 3.6 The shooting happens every year usually around harvest and planting times and the residents that are disturbed by it (200m away), have accepted it within reason. However before the farmer moderated his approach, specifically in 2019, formal complaints were raised with the authorities including calls to the police (see appendices).

4. Wheat Production

Mr Garrard states at point 5: "The paper notes that the UK is already mostly self-sufficient in wheat (p. 13), noting we already produce 88%".

Whilst this may be the case, the outlook is not particularly positive. The Guardian, under the headline: "Farmers warn 'crisis is building' as record rainfall drastically reduces UK food production", reported on 10 April 2024, a reduction in yields, leading to dependency on imports. It stated:

"Wheat production is down 15% since November, the biggest reduction in cropped areas since 2020. Oilseed rape is down 28%, the biggest reduction since the 1980s, and winter barley is down 22% at 355,000 hectares, the biggest reduction since 2020."

The question then remains, why eliminate a field which has successfully produced a crop for decades, and at the same time endanger the adjacent field through a reduction of economies of scale.

- 5) I raised further issues with the Council and they failed to respond. They have been very unhelpful, despite them owning the land where the disturbance is taking place
- 6) I contacted the local Councillors, all three of who, had failed to respond to the initial copy, stating that they hadn't received them or had gone to their junk mail
- 7) Stella Nash contacted the Environmental Health department who sent me a standard noise recording sheet to "prove" that a disturbance was staking place
- 8) I tracked down contact details for the farmer and spoke to him direct to explain the problem from our perspective
- 9) He agreed to remove the gas banger, for the time being (from last Friday 18th). You may have noticed, that it is now blissfully quiet
- 10) I am in discussions with him about on-going shooting and use of the gas banger on the land, especially from the start of next year's growing season
